Alameda	Supportive Housing Community Land Trust	8/22/19	\$6,171,599	Alameda County is requesting authorization to use up to \$6,171,599 to develop and operate a supportive housing community land trust. This model proposes to include supportive services and provides an opportunity for County Behavioral Health Care clients to live in affordable supportive housing. With this project, clients will be given the opportunity to live in a stable environment, an important element of wellness and recovery.
Alameda	Funding for CPP and Stakeholder Input Project	5/13/20	\$750,000	Alameda County requests authorization to support the Innovation-related Community Program Planning Process (CPPP). This process requires ongoing support at the county level, and in order to bring those ideas to fruition, the county is proposing to utilize dedicated staffing to design, develop and implement a more robust, streamlined and revitalized community planning process.
Butte	Physician Committed-EXTENSION	10/9/19	\$464,424	This program trains and supports primary care providers in implementing behavioral health screenings for youth into their practice and provides intervention and warm hand-offs as appropriate. Butte County is requesting additional funding for \$464,424 of innovation spending authority to address the above by incorporating additional staffing, with no changes to the project goals or purpose.
El Dorado	Senior Health and Nutrition	1/23/20	\$900,000	The project proposes to utilize existing program volunteers in the County's Senior Nutrition Program, in partnership with a contracted community provider, to engage older adults enrolled in the program by offering mental health screening, assessment and linkages to other programs and community services for those with behavioral health needs.
El Dorado	HUBS Project (EXTENSION)	3/13/20	\$250,000	The original project intended to promote interagency collaboration and partnered with County Public Health, the First 5 Commission and the County's Health and Human Services Agency by developing and placing five community hubs in local libraries within the County with the goal of increasing physical and mental health care access for families, pregnant women, and children from birth through 18 years of age. The County is requesting an additional amount of \$2,158,704 to address challenges experienced in relation to staffing, technology, and the analysis of data and reporting.

Fresno	The Lodge: Researching Targeted Engagement Approach	5/28/20	\$4,200,000	Fresno County hopes to test the success of using a dignity-first model to increase engagement in individuals who are homeless or at risk for homelessness, have severe or chronic mental illness, and who are not engaged in care due to being in the pre-contemplation stage of change.
Fresno	Project RydeWell (aka Transporation App)	5/28/20	\$1,200,000	Fresno County hopes to develop a rideshare application and provision of transportation services for behavioral health clients who experience transportation challenges when trying to access care and wellness activities in the geographically large county.
Fresno	Handle with Care+	5/28/20	\$1,527,000	This project will develop a rapid-response team to immediately provide support to children and families following a traumatic event.
Glenn	Crisis Response and Community Connections	9/23/19	\$787,535	Glenn County is proposing to explore and assess whether using a multi-disciplinary team (MDT) comprised of behavioral health clinicians, case managers and a Sheriff's Deputy, combined with prevention services to populations at higher risk for crisis, will work in a small rural county to reduce emergency department admissions, help stabilize a person earlier, and link clients to outpatient and follow-up services sooner.
Mendocino	Healthy Living Community	6/11/20	\$1,230,000	Mendocino County hopes to reduce utilization of high-level services, such as crisis contact and acute psychiatric hospitalization by providing Wellness Center style services in a residential setting.
Napa	Statewide Early Psychosis Learning Health Care Network	11/14/19	\$258,480	Napa County is proposing to join the Learning Health Care Network (LHCN) for existing Early Psychosis (EP) programs, a multi-county collaborative approved by the Commission on November 14, 2018. The LHCN utilizes an application (digital platform) to gather real-time data from clients and their family members in existing EP clinic settings, and includes training and technical assistance to EP program providers. The value of the full project will be examined through a statewide evaluation that will assess the impact of the Learning Health Care Network on consumer- and program-level metrics, as well as utilization and cost rates of EP programs.

Fresno County received Commission approval to participate in this Full Service (FSP) Multi-County Collaborative on June 24, 2019. San Mateo will utilize unspent CSS funds and -additional CSS funding to participate in the goals and activities of this Multi-County Collaborative alongside the other counties.
Sacramento	Forensic Behavioral Health	6/25/20	\$9,536,739	This project will explore the viability of adapting the Child and Family Team Model (CFT), currently utilized in the child welfare system, and expanding the teaming model for individuals in the forensic behavioral health population (individuals with a serious mental illness who are also involved in the criminal justice system).
San Bernardino	Eating Disorder Collaborative	5/28/20	\$12,113,426	This project aims to increase the awareness of eating disorders by providing training, creating a comprehensive assessment tool and multidisciplinary teams that would ultimately establish a best practice of treatment.
San Bernardino	Cracked Eggs	5/28/20	\$1,568,143	The proposed project engages peers to teach and empower participants to look past the negative aspects of their mental illness and to utilize their symptoms to create art.
San Bernardino	Multi-County FSP Project	6/5/20	\$979,634	The Counties of Sacramento, San Bernardino, Siskiyou, and Ventura are seeking innovation spending authority to develop standardization practices for FSP service programs by utilizing data driven strategies and evaluation to better coordinate, improve, and implement FSP services statewide. San Francisco	Addressing Socially Isolated Older Adults - Extension	4/9/19	\$195,787	The primary learning goal is to increase access to services by engaging and connecting vulnerable, unserved and underserved socially isolated adults with social networks and behavioral health services through peer-to-peer model support. Services for seniors at risk for mental illness will receive customized services to help meet their recovery goals, increase opportunities for relationship building, seek gainful employment, find improved housing, increase skills to find enhanced roles in the community, and provide opportunities for seniors to advocate for themselves. In order to remedy the enduring challenges, this extension proposes to utilize time and money to hire additional Peer Staff and provide professional development trainings as well as specialized trainings in understanding the needs of older adults including Understanding Trauma for Aging Seniors, Dementia Signs and Symptoms, and the Grief and Loss Process.
San Luis Obispo	Holistic Adolescent Health	10/30/19	\$660,000	In collaboration with the Community Action Partnership of San Luis Obispo (CAPSLO) and two local SLO county high schools, San Luis Obispo County proposes to incorporate mindfulness skills training and voluntary one-on-one health coaching (provided by trained Health Educators), who will provide additional support for interested students in the areas of mental, physical, and sexual health education into the current health curriculum for students aged 13-18. This new interwoven health education model will add 15 sessions of mindfulness training in conjunction with the current health curriculum to deliver a more holistic approach.
San Luis Obispo	Threat Assessment Program	10/30/19	\$879,930	San Luis Obispo is requesting authorization to develop a pilot training program for threat assessment that will adapt mainly legal and criminal based threat assessment models used in larger counties, as well as provide an opportunity for the expansion of this practice. The project proposes to deliver a new system to learn, assess, and intervene during imminent threats. It will promote interagency and community collaboration by working with law enforcement, mental health systems and the educational system to create a more cohesive approach to the prevention and intervention of school-based threats.

Siskiyou	Integrated Care Project - EXT	8/22/19	\$518,180	In February 2016, Siskiyou County received Commission approval of up to \$710,858 for an innovation project to improve the integration and coordination of health care for those receiving behavioral health care services in the County. These services were targeted towards individuals diagnosed with co-occurring serious physical health and mental health conditions. Siskiyou County is now requesting up to an additional \$518,180 of innovation spending authority to incorporate additional personnel, transportation, software to facilitate the sharing of client information, increased consultation costs, and the incorporation of additional programs into the Six Stones Wellness Centers.
Siskiyou	Multi-County FSP Project	6/5/20	\$700,000	The Counties of Sacramento, San Bernardino, Siskiyou, and Ventura are seeking innovation spending authority to develop standardization practices for FSP service programs by utilizing data driven strategies and evaluation to better coordinate, improve, and implement FSP services statewide. Fresno County received Commission approval to participate in this Full Service (FSP) Multi-County Collaborative on June 24, 2019. San Mateo will utilize unspent CSS funds and -additional CSS funding to participate in the goals and activities of this Multi-County Collaborative alongside the other counties.
Solano	Interdisciplinary and Collaboration Cultural Transformation Model (ICCTM) - EXT	6/11/20	\$1,249,797	Solano County received previous approval for their Interdisciplinary and Collaboration Cultural Transformation Model (ICCTM) innovation project that would partner with UC Davis-Center for Reducing Health Disparities (CRHD) and address health disparities for three (3) identified underserved populations; the Latino, Filipino, and LGBTQ+ communities. The approved initial budget did not include funding to directly support expenses related to the implementation of the Quality Improvement (QI) action plans that were developed in Phase III. Solano County is requesting additional spending authority to support the implementation of the QI Action plans, with no changes to the project goals or purpose.
Sonoma	Early Psychosis	6/23/2020	\$475,311	Sonoma County is requesting to join the Learning Health Care Network for existing Early Psychosis programs, a multi-county collaborative. This project looks to improve outcomes for participants in EP programs while also reducing program costs - there is lack of standardization and a lack of infrastructure to properly evaluate the fidelity to evidence-based practice and the effectiveness of these programs, making it impossible to disseminate best practices across programs.

Stanislaus	NAMI on Campus	4/2/20	\$923,259	This project aims to test a new method for reducing stigma and increasing access to mental health services for youth. Stanislaus County will pair the NAMI on Campus-High School model with an existing, community-based successful youth coalition that advances youth leadership, development and organization to advance the mental health outreach efforts in high schools across the county.
Sutter-Yuba	iCARE (Innovative & Consistent Application of Resources and Engagement)	9/26/19	\$5,228,688	Sutter-Yuba County Behavioral Health (SYBH) is proposing to create a mobile team to engage with individuals prior to and after hospitalization. This project will focus on increasing consumer engagement for individuals who recurrently access emergency room and crisis services when experiencing severe and chronic behavioral health symptoms. Additionally, with the use of MHS A Prevention and Early Intervention funds the County will leverage this project to provide community-wide training focusing on mental health in an effort to educate their community and reduce stigma.
Tulare	Advancing Behavioral Health	6/11/20	\$6,000,000	This project will evaluate and compare the outcomes of consumers with Specialty Mental Health Services both within a traditional clinical setting and in an urban community setting. Services will be provided through a Whole Person Care (WPC) delivery system model by a multidisciplinary team (MDT) in both settings.
Ventura	Multi-County FSP Project	6/5/20	\$979,634	The Counties of Sacramento, San Bernardino, Siskiyou, and Ventura are seeking innovation spending authority to develop standardization practices for FSP service programs by utilizing data driven strategies and evaluation to better coordinate, improve, and implement FSP services statewide. Fresno County received Commission approval to participate in this Full Service (FSP) Multi-County Collaborative on June 24, 2019. San Mateo will utilize unspent CSS funds and -additional CSS funding to participate in the goals and activities of this Multi-County Collaborative alongside the other counties.
Ventura	FSP Multi-Platform Data Exchange	6/25/20	\$2,011,116	Ventura County hopes to establish shared data streams. These data streams will enable Full-Service Partnership (FSP) client information on law enforcement encounters, hospital stays, health care services and homeless services, to be shared between systems. This will allow the programs working with FSP clients in Emergency Services, Primary Health, Human Services Agency, and the Sheriff's office to provide comprehensive service coordination and valid data reporting for FSP performance outcome measures.
